



## WEED ABATEMENT COMPLAINT FORM



ALL COMPLAINTS REGARDING WEED ABATEMENT SHOULD BE COMPLETED USING THIS FORM. ONCE THE FORM IS PROCESSED AND REVIEWED BY A FIRE INSPECTOR, AN ON-SITE INSPECTION OF THE PARCEL WILL BE CONDUCTED. **ALL WEED VIOLATIONS MUST BE VISIBLE FROM THE STREET.** DUE TO LAWS PROHIBITING ILLEGAL SEARCHES, THE PETALUMA FIRE DEPARTMENT AND FIRE PREVENTION BUREAU WILL NOT BE ABLE TO CLIMB FENCES OR ENTER A PROPERTY VIA THE BACKYARD TO CONFIRM WEED COMPLAINTS. AFTER AN INSPECTION, IF A SITE IS DEEMED TO BE A FIRE HAZARD, THE FIRE PREVENTION BUREAU WILL REQUIRE THE OWNER TO TAKE APPROPRIATE ACTIONS TO MITIGATE THE HAZARD.
